CHECKLIST (questionnaire) FOR A COUPLE WHO WANTS TO CONCLUDE A MARRIAGE AGREEMENT

- 1. Is this the first or second, third marriage?
- 2. What country are you a citizen of?
- 3. In what country do you plan to live and buy property?
- 4. Have you ever entered into marriage contracts before?
- 5. Why do you want to sign a marriage contract? What is the purpose of signing such document?
- 6. Do you understand the legal consequences of signing a marriage contract?
- 7. What property issues would you like to settle:
 - · property rights for unfinished construction;
 - · immovable property (apartments, houses, land);
 - movable property (vehicles, cash (cryptocurrency, etc.), money in ordinary bank and / or savings accounts, interest on deposits, shares, intellectual property, corporate rights and income from corporate rights, property rights claims in other persons (cash loans), valuables: paintings, antiques, jewelry, pets;
 - income from real estate or movable property (royalties, dividends, monetary compensations, insurance amounts, etc.), personal non-property and property rights of the spouses; business activities;
 - · salaries and bonuses, pensions, fees, other payments;
 - subjects of professional training of each spouse (musical instruments, office equipment, medical equipment, etc.)
 - · other assets?
- 8. Is it important for you to obtain the written consent of the other spouse when registering property ownership?
- 9. Do you want to provide in the contract the amounts in case of expenses above which it is necessary or not necessary to obtain the written consent of the other spouse?
- 10. Do you want property that will be acquired in marriage or has already been acquired in marriage, be separate or owned / divided between you not in equal shares?
- 11. What property was acquired by each party before marriage into personal private property? Do you want to confirm this in the provisions of the marriage contract?
- 12. Who is the title owner of the common property (which of the spouses has registered movable and / or immovable property), the legal regime of which you want to change in the marriage contract?

- 13. Are there third parties who have certain property rights, such as creditors? (for example, the apartment is mortgaged). If so, you must obtain appropriate written permission from such persons.
- 14. Would you like to provide monthly financial support to the other spouse?
- 15. Do you have children? Will their non-property rights or property rights be violated by the terms of the marriage contract?
- 16. Do you want to determine who will be responsible for the joint and / or personal debt obligations of one of the spouses?
- 17. Would you like to regulate in the marriage contract the occurrence of property sanctions for violation of non-property agreements (for example, reduction of the share or financial sanctions for betrayal)? Other?
- 18. Would you like to regulate the right to use the property of one of the spouses by the other spouse or your relatives?
- 19. Have you entered into any other agreements relating to the property that is the subject of the marriage contract? If so, which ones, when?
- 20. Are you forced to enter into this marriage contract?
- 21. Did you know that it will be possible to make changes to the marriage contract only by mutual consent or through the court?

Documents:

- 1. Marriage certificate / Certificate of application for marriage registration
- 2. Passports of husband and wife
- 3. Registration numbers of taxpayers' registration cards (code) of husband and wife
- 4. Legal documents on the property that is the subject of the marriage contract
- 5. Child's birth certificate (if any)
- 6. In addition, other documents may be required, depending on the desired conditions of the marriage contract (determined by the results of responses to the checklist (questionnaire) and consultation with a lawyer).
